Applicant on behalf of him/herself and his/her heirs, successors and assigns, hereby releases fully and forever, and discharges the Janesville Farmers Market Inc., and each and every of their perspective officials, officers, employees and agents from any and all claims, actions, causes of action, damages, costs and/or expenses of any kind or nature, including attorney's fees, however caused and incurred by the applicant, arising from or in any way connected with the issuance of permission to Applicant to be a vendor at the Janesville Farmers Market, Inc., and the resulting operation of Applicant's business at said Market.

Applicant hereby agrees to indemnify and hold harmless the Janesville Farmers Market Inc., and each and every of their respective officials, officers, employees and agents from and against any and all claims, actions, causes of action, damages, costs and/or other expenses of any kind or nature, including attorney's fees, arising from or in any way connected with the Applicant's use of public space, operation of Applicant's business and the use of the same by Applicant's agents, members, partners, associates, contractors, servants, employees, invitees, and licensees.

The undersigned declares under penalties of perjury that the factual information furnished by him/her in Applicant's Application is true, accurate and complete to the best of his/her knowledge.

Applicant shall be responsible for compliance with all laws, rules, regulations and ordinances governing the sale of all goods at the Janesville Farmers Market, Inc.

The Janesville Farmers Market, Inc., reserves the right to terminate the Market Contract of any or all Vendors at any time without cause and without reimbursement of fees paid.

INSTRUCTIONS

Product Guidelines:

- ~ All work must be original and made by the applicant.
- ~ Significant alteration of commercial components in any work is required.
- ~ Works must be safe, have a decent life expectancy, and exhibit quality of craftsmanship.
- ~ In works made from or including dried flowers, the flowers must be grown by applicant.

Unacceptable work includes:

- ~ Work made from kits.
- ~ Work made from molds not made by applicant.
- ~ Work made by someone other than applicant (including commercially made products, imports, and products bought for resale).

Criteria for Selecting Artists:

- ~ **Product Guidelines:** Work meets guidelines established above.
- ~ **Price Range:** Interested in having reasonably priced pieces available for sale.
- ~ **Variety of Artists:** Consideration will be given to being inclusive to a variety of qualified artists.
- ~ **Previous Participation:** Consideration will be given to artists past participation with *A Celebration of the Arts*.

Site Information:

- ~ The Janesville Farmers Market is located at the intersection of Main and Milwaukee and Wall Streets.
- ~ Water is available at the site.
- ~ Electricity is available at some booth spaces.
- ~ The Farmers Market Manager will be available to answer questions, assist

with traffic control, and ensure the smooth operation of the fair.

Booth and Sales Information:

- ~ Booth spaces are 10' x 10'.
- ~ Cost is \$15.00 per Saturday, though seasonal discounts will be made for interested artists.
- ~ Commissions on sales will not be collected.
- ~ Although exhibitors are required to be present in the booths, booth sitters are available for restroom breaks.
- ~ Demonstrations by exhibitors are encouraged.
- ~ Exhibitors wishing to share a booth must submit separate applications, noting that they wish to share one booth.
- ~ All displays must be set-up by 7:45AM and exhibitors may not start tearing down until 1 PM.
